

PARENT/PLAYER AGREEMENT – READ BEFORE SIGNING

My son has been selected to play on a competitive travel team through the **G5 BASEBALL** Club, and I understand and I agree to the following:

1. **There is no guaranteed playing time.** This is a competitive baseball club and winning games is a primary objective. I understand, there are many factors that determine the amount of playing time for my player, including, but *not limited to*, disciplinary action, poor attitude, late arrival for warm-ups, missed practices etc. I also understand that this team may/will utilize substitute players and/or a DH at any time.
2. I understand that the average monetary commitment for a competitive travel team is in excess of \$750 and will have **ALL DUES** in on time. I may be required to fundraise.
3. I agree and understand that all monies paid are **NON-REFUNDABLE**.
4. I understand the commitment level that is required to be part of this club, and that my player's absence at practice and tournaments may interfere with the overall experience of his teammates.
5. I understand that this team may utilize guest players/alternates for tournaments. These guest players *may encroach* upon my player's playing time. I know that the objective of guest players is to enhance the overall competitiveness of this team. I hereby agree to this procedure.
6. **I understand that disagreements with umpires, opposing coaches and players shall be handled by my Head Coach. I will not be argumentative, verbally abusive, or aggressive towards an umpire or opposing coach.** I will respect all players/teammates, opponents, coaches, parents, umpires and myself. Any misconduct on my part will be met with appropriate action which could include my child's suspension and/or removal from the team.
7. I understand that I am not to coach my player from the stands or outside the dugout during games and I will not distract any players during games (i.e. on deck circle). I agree to let the coaches do the coaching.
8. I understand that I will not approach the coaches with any concerns on *game days*. I agree these matters should be handled at another time and location when emotions are calm and under control – **24 hour rule**.
9. The selection for this team is only for the 2020 - 2021 season.
